Mayor Baker advised the council that due to his new work schedule he is unable to fulfil his position as Mayor of Farmington, his resignation will go into effect at midnight on the 31st of May 2019. He also advised them that late last week he accepted the resignation of the Clerk-Treasurer Barbara Dial-Flomer effective midnight on the 31st of May 2019.
