WHITMAN COUNTY AUDITOR

CALLING FOR ELECTION ON EXCESS LEVY PROPOSITIONS.

WHEREAS: The TOWN COUNCIL OF THE TOWN OF FARMINGTON has determined that the Regular Levy for the TOWN OF FARMINGTON for the year 2009, will be insufficient to meet the ordinary and necessary operating expenses the TOWN expects to incur, especially in the Current Expense Fund and City Street Maintenance Fund.

WHEREAS: The TOWN COUNCIL has determined that the most expedient means of generating additional Revenue for the year 2009, is to initiate an Excess Tax Levy.

NOW THEREFORE: It is hereby resolved by the MAYOR AND COUNCIL OF THE TOWN OF FARMINGTON, WHITMAN COUNTY, WASHINGTON, as follows:

- That a SPECIAL ELECTION shall be had and held on or about November 4, 2008, at the regular polling 1. place within the COUNTY.
- That the Clerk-Treasurer present the necessary Ballot Titles to the WHITMAN COUNTY AUDITOR 2. within the required time by Law for said AUDITOR'S review and approval.
- The content of the proposed Ballot Titles for the aforementioned Special Levies be substantially as follows: 3.

## **PROPOSITION #1**

SHALL THE TOWN OF FARMINGTON LEVY A SPECIAL TAX OF \$12,000. AN ESTIMATE \$ 2.24. PER \$1,000 OF THE 2008 ASSESSED VALUATION, FOR CITY STREET MAINTENANCE FUND, FOR COLLECTION IN 2009, BE APPROVED?

SHALL THE TOWN OF FARMINGTON LEVY A SPECIAL TAX OF \$5,000. AN ESTIMATED \$0.93. PER \$1,000 OF 2008 ASSESSED VALUATION, FOR SPECIAL EQUIPMEN FUND, FOR COLLECTION IN 2009 BE APPROVED?
