




RE: Alley Vacation

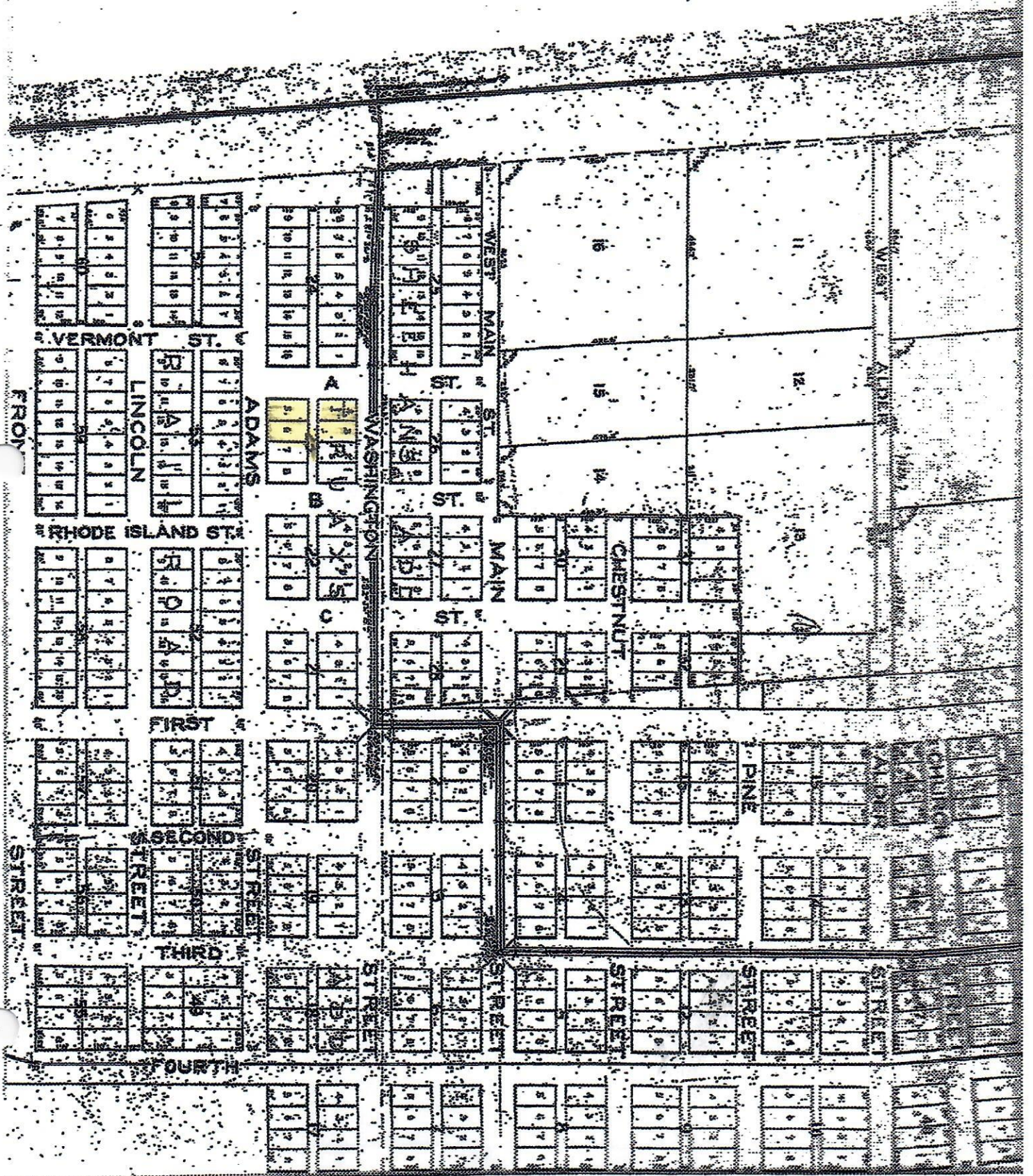



ORDINANCE NO. 228-14

AN ORDINANCE OF THE TOWN OF FARMINGTON, WASHINGTON, vacating the 20 foot alley now existing between Lots 3-4 & 5-6, Block 23, Truaxe Addition, Town of Farmington.

WHEREAS, John Ewing and Noreen Ewing, as the owners of lots 3-4, & 5-6, Block 23, Truax Addition, Town of Farmington, have petitioned the Town Council to vacate the alley now existing between Lots 3-4, & Lots 5-6, Block 23, Truax Addition, Town of Farmington; and,

WHEREAS, the Town Council by resolution fixed a date and time for a hearing on the petition; and

WHEREAS, after notice duly given as required by law, a public hearing was held on the petition, commencing at 6:00 p.m. on April 21, 2014, and the Town Council being fully advised in the premises, now, therefore,

BE IT ORDAINED by the Town Council of the Town of Farmington as follows:

Section 1. Those portions of the alley running between Lots 3-4, and Lots 5-6, Block 23, Truax Addition, Town of Farmington, Whitman County, Washington, are vacated, reserving unto the Town of Farmington a perpetual, non-exclusive easement over, across, and under the alley for utilities.

Section 2. Upon receipt by the Town Clerk from the owners of Lots 3-4, and Lots 5-6, Block 23, Truax Addition, Town of Farmington, of the cash sum of \$1000.00, together with such sums as may be necessary for payment of the real estate excise tax statement processing fee and recording costs, the Town Clerk shall forthwith cause a certified copy of this ordinance to be filed for record in the office of the Whitman County Auditor.

Section 3. This ordinance shall become effective upon the publication thereof as required by law, and upon the filing of a certified copy in the office of the Whitman County Auditor.
