TOWN OF FARMINGTON ORDINANCE NO. 259-23 ADOPTION OF THE 2024 OPERATING BUDGET December 18, 2023

AN ORDINANCE OF THE TOWN COUNCIL OF THE TOWN OF FARMINGTON, WASHINGTON, ADOPTING THE BUDGET FOR 2024, Setting forth appropriations and estimated revenues and adopting, by reference, the final budget for 2024.

THE TOWN COUNCIL OF THE TOWN OF FARMINGTON DO ORDAIN AS FOLLOWS:

SECTION 1: The Mayor of the Town of Farmington completed and placed on file with the Clerk a preliminary budget, including estimates of revenues and expenditures for operations of the town for the fiscal year beginning January 1st, 2024 and ending December 31st, 2024.

SECTION 2: The Town Council has made such adjustments and changes to said preliminary budget, as it deems necessary or proper at the time.

SECTION 3: The Town advertised and properly held the statutory public hearings on November 20th, 2023, and December 18th, 2023.

SECTION 4: The proposed budget, as revised, was fixed by the Town Council on December 18th, 2023, and is now on file in the Office of the Clerk, and is hereby adopted by fund, and incorporated herein as set forth, in full, in this ordinance.

SECTION 5: The following is a summary of the totals of estimated revenues and appropriations for each separate fund and the aggregate totals for all funds combined:

SECTION 8: This ordinance shall take effect and be in force after its adoption by the Town Council.
